From February 19-23 of this year, the 8th International Abstract State Machines Workshop took place in Las Palmas de Gran Canaria on the Canary Islands (Spain), organized by us as part of Eurocast 2001. The intensive three-days program consisted of 24 contributed papers and three invited lectures, by Yuri Gurevich ("Abstract State Machines: Theory and Applications"), Joseph Sifakis ("Some Trends in Modeling Real-Time Systems"), and Egon Börger ("Design for Reuse via Structuring Techniques for ASMs"). They critically evaluated 19 papers submitted after the workshop, providing 64 reviews which resulted in the present set of contributions to this issue.

As has been characteristic for ASM workshops over the years, the covered themes range from theoretical foundations to industrial applications. On the theoretical side, the reader can find four new conceptual developments. In "Partial Updates: Exploration" (by Y. Gurevich and N. Tillmann) a solution is proposed for the partial update problem for counters, sets and maps. In "Verification of ASM Refinements Using Generalized Forward Simulation" (by K. Schellhorn) a practical general proof principle for ASM refinements using commuting diagrams is distilled which came out of the KIV verification of the refinement correctness proof linking the ISO Prolog ASM to the WAM ASM. In "A Complete Logic for Abstract State Machines" (by R.F. Stärk and S. Nanchen) a new logic for non-distributed, deterministic, structured ASMs with sequential composition and recursive submachines is developed on the basis of an atomic predicate for function updates and of a definedness predicate for the termination of the evaluation of transition rules. In "A Neural Abstract Machine" (by E. Börger and D. Sona) Alessandro Sperduti's question is answered whether the fundamental features can be made explicit which are common to the multitude of current neural network models and implementations.

On the practical side, the reader finds a discussion of fundamental questions concerning the practicability, adequacy and maintainability of the recent ASM definition of the International Telecommunication Union standard for SDL-2000 in the paper "Formal Definition of SDL-2000 - Compiling and Running SDL Specifications as ASM Models" (by R. Eschbach, U. Glässer, R. Gotzhein, M. von Löwis, A. Prinz). In "ASM-Based Testing: Coverage Criteria and Automatic Test Generation" (by A. Gargantini and E. Riccobene) ASMs are used for the first time to define and analyze methods for the generation of test suites from high-level specifications. In "Compiling Abstract State Machines to C++" (by J. Schmid) a compilation scheme is detailed which transforms algebraic data types, pattern matching, functional expressions, dynamic functions, and simultaneous updates in an efficient way to C++ code, describing a compiler which has been built for, and successfully used in, a middle sized industrial project at Siemens Corporate Technology. In "The Location Consistency Memory Model and Cache Protocol: Specification and Verification" (by C. Wallace, G. Tremblay, and J.N. Amaral) the reader finds an interesting use of an appropriate ASM model for what the title of the paper announces.
